



No. 2/50/2013-1Pension.- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules to further amend the **Punjab Civil Services Rules Volume-II**, in their application to the State of Haryana, namely:-

1. These rules may be called the **Punjab Civil Services Volume-II (Haryana Amendment) Rules, 2015**.

2. In the **Punjab Civil Services Rules, Volume-II, in Appendix-I, in Family Pension Scheme, 1964, in para 4-B,**-

- (i) sub-para (viii) shall be omitted;
(ii) for sub-para (xi), the following sub-para shall be substituted, namely:-

“(xi) this benefit shall be admissible to the eligible disabled children whether born before or after retirement”; and

(iii) the following explanation shall be inserted the end, namely:-

“Explanation. - An eligible person receiving family pension, shall receive the same for the benefit of all the eligible persons of the family.”

संख्या 2/50/2013-1 पेंशन- भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, पंजाब सिविल सेवा नियम जिल्द - II, हरियाणा राज्यार्थ, को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं अर्थात:-

- (1) ये नियम पंजाब सिविल सेवा जिल्द - II (हरियाणा संशोधन) नियम 2015, कहे जा सकते हैं ।
- (2) पंजाब सिविल सेवा नियम, जिल्द - II में, परिशिष्ट-1 में, पारिवारिक पेंशन स्कीम, 1964 में, पैरा 4-ख में,-

- (i) उप-पैरा (viii) का लोप कर दिया जाएगा;
- (ii) उप-पैरा (xi) के स्थान पर, निम्नलिखित उप-पैरा प्रतिस्थापित किया जाएगा, अर्थात:-

“(xi) यह लाभ पात्र अशक्त बच्चों को, चाहे सेवानिवृत्ति से पहले या बाद में पैदा हुए हों, अनुज्ञेय होगा;” तथा

- (iii) अन्त में निम्नलिखित व्याख्या जोड़ दी जाएगी, अर्थात:-
“व्याख्या:- पारिवारिक पेंशन प्राप्त करने वाला कोई पात्र व्यक्ति परिवार के सभी पात्र व्यक्तियों के लाभ के लिए उसे प्राप्त करेगा।”
