



**Subject:- Payment of Dearness Allowance to Haryana Government Employees on revised scales of pay i.e. 113% to 119% effective from 01.07.2015.**

Sir/Madam,

I am directed to invite a reference to Finance Department circular letter No. 4/1/2009-5FR/8555 dated 5<sup>th</sup> May, 2015 on the subject noted above and to say that the Governor of Haryana is pleased that the Dearness Allowance payable to Haryana Government employees on revised scales of pay shall be enhanced from the existing rate of 113% to 119% of the pay w.e.f. 1<sup>st</sup> July, 2015.

2. The additional instalment of DA payable under these orders shall be paid in cash to all Haryana Government employees for the month of October, 2015 paid in November, 2015.

3. The payment of arrears of enhanced Dearness Allowance for the month from 01.07.2015 to September, 2015 shall be made in the month of November, 2015.
