**Subject: Implementation of Government decision on pension and pension related matters - Revision of pension/family pension-documents regarding.**

The Dakshin Haryana Bijli Vitran Nigam is pleased to adopt the Haryana Govt. two nos. notifications dated 17.4.09 respectively i.e. Haryana Civil Services (Revised Pension) Part-I Rules, 2009 & Haryana Civil Services (Revised Pension) Part-II Rules, 2009, circulated by the Financial Commissioner & Principal Secretary to Government Haryana, Finance Department vide letter No. 2/51/2008-1 Pension dated 17.4.2009 on the above noted subject.


However, the minimum and maximum ceiling of pension/family pension is subject to minimum of Rs. 3500/- w.e.f. 1<sup>st</sup> January, 2006 and maximum up to 50 percent of highest pay i.e. Rs. 79,000/- and in no case, be lower than fifty percent of the minimum of the pay in the pay band + grade pay in the corresponding revised scale in terms of revised pay scales circulated by DHBVN vide office order no. 200/Finance dated 28.2.09.

Further, while fixing the revised pension/family pension as per annexure of the State Govt. Notification at CP- 1 as specified in sub Para 5 of Para 6 the pay scale applicable in the erstwhile HSEB now DHBVN the pre-1996, pre-2006 and post-2006 may also be kept in view.

Copies of the said notifications are sent herewith for reference & further necessary action in your office.

These instructions may be got noted from all concerned dealing with the pension cases.
